Hence certified copies are required.</p>
<b>Reply</b>	<p>Desired data is not maintained as PWD Roster does not prescribe for maintenance of disability sub-category information like OL/ OA etc.</p>

<b>Query</b>	<p>Furnish the list containing name with designation of orthopedically handicapped employees <u>with one arm disability</u> working as Electrical Engineer/ Asstt. Electrical Engineer in Central Govt and Central PSU and <u>criteria for selection</u></p>
<b>Reply</b>	<p>For 1<sup>st</sup> part of the question, please refer to our reply against RTI Application dtd. 28.11.2017..</p> <p>For 2<sup>nd</sup> part i.e. criteria for selection the following are mentioned:</p> <p><b>Graduate Engineers in Electrical discipline are mainly recruited as Executive Trainee on all India Open competition basis. For Executive Trainee-Electrical post, the selection criteria is as given below :</b></p> <p>The selection is based on GATE Marks (out of 100) – 85% weightage, GD -3% weightage, Interview- 12% weightage.</p> <p>Qualifying marks in GATE is as decided by GATE Conducting body.</p> <p>GD has no qualifying marks.</p> <p>Interview has qualifying marks of 40% for Un-Reserved vacancies and 30% for Reserved vacancies.</p> <p>Qualified candidates in GATE are shortlisted for GD &amp; Interview based on their GATE Marks and those who qualify subsequently in interview are empanelled for medical examination and appointment in order of merit.</p> <p>PWD (OH-OL / HH) candidates are allowed age relaxation up to 10 years (irrespective of reservation) over and above category age limit. They are exempted from payment of application fees. In GATE, the qualifying marks for PWD candidate is less than the qualifying marks for General category. In POWERGRID interview, the qualifying marks for PWD (OH-OL/ HH) candidates is 30% subject to reservation of vacancy. ### RELAXATIONS AND CONCESSIONS

1. Reservation/ relaxation/ concession to OBC (NCL)/ SC/ ST/ PwD/ Ex – SM/ J&K Domiciled/ Victims of riots shall be as per Government of India directives.
2. Persons suffering from not less than 40% of the relevant disability shall only be eligible for the benefit for PwD.
3. Relaxation in Marks in essential qualification for SC/ST/PwD candidates: Qualifying Marks in essential qualification is relaxed to pass marks for posts reserved for the respective category as per the final detailed advertisement to be issued before commencement of online registration.

## SELECTION PROCESS

The Selection Process consists of marks obtained (out of 100) in the corresponding paper of GATE 2018, Group Discussion & Personal Interview.

Eligible candidates will have to appear for the corresponding paper of GATE 2018, i.e. Electrical Engineering (EE)/ Electronics and Communication (EC) / Civil Engineering (CE)/ Computer Science and Information Technology (CS)

Candidates qualified in corresponding paper of GATE 2018 shall only be eligible to be considered for the next stage of selection. Qualifying marks in GATE-2018 shall be as decided by GATE-2018 conducting authority.

Qualified candidates shall be short-listed category-wise for Group Discussion & Personal Interview based on their **normalized marks out of 100** in GATE 2018, in the corresponding paper.

Candidates shall obtain information about their status through their login at the POWERGRID Online Application System. Shortlisted candidates shall be able to download their interview call letter and other relevant documents through the candidate login.

Candidates shortlisted for the Group Discussion and Interview shall be required to bring the documents as mentioned in their interview call letter.

Candidates must qualify in the Personal Interview in order to be considered for empanelment. The qualifying % in interview for different categories are as mentioned below:

### Empanelment of Candidates

Candidates who qualify in the Personal Interview will only be adjudged suitable for empanelment. Therefore it is again reiterated that candidates will have to qualify in GATE 2018 and in Personal Interview separately in order to be considered eligible for empanelment.

**Please note that only GATE 2018 score (Normalized Marks out of 100) is valid for this recruitment process. GATE score of 2017 or prior is not valid.**

The offer of appointment shall be issued to the suitable candidates in the order of category wise merit and based on the requirement. Selected candidates shall be notified through their login in Online application system.

Appointment of selected candidates will be subject to their being found medically fit in the Pre-Employment Medical Examination to be conducted as per POWERGRID Norms and Standards of Medical Fitness.
