The cut off for qualifying the examination being 68 out of 170.</p> <p>I have not received the e-mail for interview.</p> <p>I want the following information from POWERGRID:</p> <p>1- Reason for delay in interview process i.e. 1 year have been elapsed from the date of notification 2- Whether interview have been called for the post of ET-Finance 3- The contact number and e-mail ID for further reference 4- Whether post of ET-Fiance is valid or not</p>
<p>Reply</p>	<p>As per the advertisement for the post of ET-Finance, all information pertaining recruitment is to be seen on candidate login home page.</p> <p>The information available on the candidate login home page of Sh Ganesh is enclosed at Annexure-I.</p> <p>The same indicates the following:</p> <ul style="list-style-type: none">• Category of Sh Ganesh – General (<i>Hence considered against UR vacancy</i>)• Marks secured by Sh Ganesh in CBT in Section-1 is 70.00 out of 120 (<i>i.e. 58.33%-passed</i>)• Marks secured by Sh Ganesh in Section-2 is 16.750 out of 50 (<i>i.e. 33.5% - passed</i>)• Total Marks secured by Sh Ganesh is 86.750 out of 170 (<i>i.e. 51.029%- passed</i>)• Qualifying Marks in test was 68/170 i.e. 40% in total. <i>Hence Sh Ganesh had passed in the test.</i>• Cut off % for UR Category for shortlisting for GD & Interview is 66.912 % <p>Therefore % of Marks secured by Sh Ganesh is less than the cut off % ($51.029\% < 66.912\%$) for shortlisting for GD & Interview.</p> <p>The above information itself is more than sufficient to indicate that Sh Ganesh was not shortlisted for GD & Interview because of falling short of cut off.
