### ORDER

#### **Grounds of Appeal**

The Appellate Authority has received an online appeal bearing number PGCIL/A/2018/60007 dated January 14<sup>th</sup>, 2018 from one Aspirant seeking final cut-off including written, Group Discussion and Interview marks for selected candidates in Power Grid against advertisement number CC/06/2016.


Earlier, an application dated 13<sup>th</sup> December 2017 was filed by the appellant herein with the CPIO, under RTI Act, 2005 seeking information regarding interview and Group Discussion marks in the exam conducted by POWERGRID under aforementioned advertisement for registration ID- 100381, & roll number- 1010313233.

On receipt of the Appeal, the details were sought from the CPIO. The CPIO informed that the information was denied as the name mentioned in the RTI application did not match with the name mentioned against the roll number and the registration ID provided by the applicant.

**Decision**

I am of the view that the information sought by the appellant in his appeal was not part of original RTI application and in case the appellant wishes to seek any information other than the information already provided the same may be requested by filing fresh RTI application with CPIO.

The Appeal is accordingly disposed of.

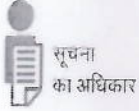
