Reply to RTI Queries by Sh. Amrit Kumar Gupta

Query 1	Why the different marks percentage criterion for the same post for the diploma and BE/B.Tech holder in the PGCIL recruitment?
Reply	The percentage criterion for the post of Diploma Trainee for candidates having BE/BTech degree has been kept in par with the percentage criterion for the post of Executive Trainee which is a superior post.
Query 2	According to application form recruitment is kept as 70% for diploma holders and 65% for BE/B.Tech as well same post (Diploma Trainee post in PGCIL)
Reply	The above is a statement and does not qualify as query under RTI Act 2005.
Query 3	As we know that this post is only released for the diploma holders mainly than why you have allowed it for the BE/B.Tech holders at minimum percentage mark as compare to the diploma holders.
Reply	BE/BTech holders in the same discipline are not disqualified for the post of Diploma Trainee as BE/BTech are superior courses.
Query 4	According to application form every eligible criterion have kept same except percentage mark as compared to the diploma holders.
Reply	The above is a statement and does not qualify as query under RTI Act 2005.
Query 5	We want that eligibility must be same for the same post for diploma and BE/BTech holders as well. But it is not mention in the application form.
Reply	The above is a personal opinion of the requestor and does not qualify as query under RTI Act 2005.
Query 6	If you want skill full engineer then you should take it through GATE basis directly.
Reply	The above is a personal opinion of the requestor and does not qualify as query under RTI Act 2005.
