

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is informed that the POWERGRID Board of Directors in their meeting held on 02.11.2017 have accorded approval for the following:

- Investment Approval for "Eastern Region Strengthening Scheme XX (ERSS-XX)" at an estimated cost of ₹358.83 Crore with commissioning schedule of 30 months from the date of investment approval;
- 2. Investment Approval for "Refurbishment of Vindhyachal HVDC System under Additional Capital Expenditure [Part (b)- Converter Transformer]" at an estimated cost of ₹22.78 Crore with commissioning schedule of 17 months from the date of investment approval; and
- 3. Formation of Joint venture with Uttar Pradesh Power Transmission Corporation Limited (UPPTCL) on 50:50 equity participation basis for taking up Intra-State Transmission System in Uttar Pradesh.
