ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60010 dated 29th January 2018 from Sh. Kaushik Agarwal. Earlier, an application bearing number PGCIL/R/2018/50007 dated 4th January 2018 was filed by the Appellant herein with the CPIO, Corporate Centre, POWERGRID under RTI Act, 2005 seeking information regarding his interview and Group Discussion marks in the exam conducted by POWERGRID under Advt. No. CC/06/2016. The information was provided by CPIO vide letter dated 12th January 2018. The appellant has filed an appeal seeking following information:

"Final cut-off i.e. including written, Group Discussion and Interview marks, for selected candidates in PGCIL."

Decision

I have perused the record. It can be seen that vide his RTI application dated January 4, 2018 the appellant had sought information regarding his Interview and Group Discussion marks, and the same was provided by CPIO vide letter dated January 12, 2018.

Now in appeal the appellant is seeking information on Final cut-off for selected candidates in PGCIL. I am of the view that the information sought by the appellant has already been provided and in case the appellant wishes to seek any information other than the information already provided the same may be requested by filing fresh RTI application with CPIO.

The Appeal is accordingly disposed of.

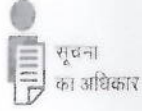
