1	Kya PGCIL follow apprenticeship act of Govt. of India? Ans: yes/no	Yes
2	According to Govt of India + MHRD, apprenticeship through (regional wise) kya PGCIL work under NATS +BOAT? Yes/no	POWERGRID does not work under NATS / BOAT. POWERGRID is a Government of India Enterprise under Ministry of Power. For engagement of apprentices, POWERGRID follows the guidelines given by NATS / BOAT.
3	According to Govt of India +MHRD+NATS+BOAT allow apprentices for B.Tech student must be 3 years back old passed session (2015/16/17) but PGCIL is not allow for 3 year back old student PGCIL allow only 2 year back old passed session student 2016/17) why+how?	As confirmed by Board of Apprenticeship & Training, it is upto the employer to have their own selection criteria for engaging apprentices within the broader Govt. Guidelines, such as age limit, date of passing, % marks and other qualification criteria as per organizational requirement.
		Accordingly, with a view to engage bright and young talent, many organizations both in private and public also have set their own criteria for engagement of apprentices.
		In line to above, the competent authority in POWERGRID has approved inviting Graduate and Diploma Applicants for apprenticeship within two year since the date of passing of final year examination which is permissible within the broader guideline as mentioned above.
	PGCIL Haryana + PGCIL Arunachal Pradesh allow apprenticeship for through NATS+BOAT (north region). But PGCIL website all regions is not allow for 3 year back old student 2016/2017. Why +how. PGCIL website is automatically set date for last 2 year old student.	This guideline is being uniformly followed throughout POWERGRID.
	All govt. India + MHRD+ NATS+BOAT (all region) + any PSU company + Private +State Govt company allow apprenticeship for 3 year back old student (2015/16/17). Then why PGCIL allow kahi 2 year back old student & kahi 3 year back	As mentioned in point no.3 & 4.
