

RTI by Shri Rahul Chauhan, Dhampur, Bijnor, UP

During service bond period, in both case diploma trainee (supervisory category) and executive trainee, if an employee of the POWERGRID applied for direct recruitment to UPSC and immediately informs to the head of office/department, that he has applied for the direct recruitment to UPSC.

Can the POWERGRID allow to that person to appear in the exam or permission can be denied to appear in the examination. If denied to give permission, please give reasons why does the POWERGRID not give the permission to appear in the examination, which is conducted by UPSC where NOC is not required, only head of office/department needs to be informed (if employee meets all eligibility condition according to UPSC advertisement).

Reply: This is a question on future event which is yet to happen and accordingly answer to this query does not qualify as "information" as per clause 2(f) of the RTI Act 2005.

The OM dt. 23.12.2013 attached with the RTI is of Deptt. of Personnel & Training which is applicable to Government Servants.

As per Service Rules of POWERGRID and terms & condition of appointment, if an employee is under any type of bond obligation, no application will be forwarded for outside employment during the bond period.

As per Service Agreement Bond (Executive Trainee) in case he fails to complete his training successfully and/ or serve the Company for the stipulated period of three years thereafter, he and his surety shall jointly and severally compensate the company for salary, joining expense, TA/DA medical expenses etc. paid during the training period and training expenses incurred by the Company on account of and in connection with his training and this amount will be recovered from him if he leave the Organization within the training/bond period. However, the total amount recoverable under this clause shall not exceed bond amount.
