ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60017 dated 27th February 2018 from Sh. Gurpreet. Earlier, an application bearing number PGCIL/R/2018/50031 dated 28th January 2018 was filed by the Appellant herein with the CPIO, Corporate Centre, POWERGRID under RTI Act, 2005 seeking information regarding total vacant posts in POWERGRID for AEs and JEs. The information was provided by CPIO vide letter dated 5th March 2018. The appellant has filed an appeal mentioning that he has not received any response within the stipulated time period of 30 days.

Decision

I have perused the record. It can be seen that vide letter CP/RTI/2017/522 dated 5th March 2018 CPIO informed appellant that the advertisement for recruitment of AEs and Diploma Trainees (Regularized as JEs) are being published on POWERGRID's website along with national (In case of AEs) and concerned local newspapers (In case of Diploma Trainees) which includes number of vacancies. Since appellant did not received relevant information with in stipulated time of 30

get the information within stipulated period of 30 days. CPIO is directed to provide information in future within stipulated time.

The Appeal is accordingly disposed of.
