Point no. 3: please provide the names of country to which Indian Government had signed MOU for electrical energy transmission

Reply:

Corporate Commercial Department has not signed any MOU with other countries for the purpose of electrical energy transmission. However, the following Bulk Power Transmission Agreements (BPTAs) have been signed with Bangladesh for electrical energy transmission between India and Bangladesh.

1. BPTA dated 26.07.2010 for 400 kV Double circuit Behrampur- Bheramara line
2. BPTA dated 04.05.2015 for 400 kV Double circuit Surjyamaninagar - Camilla (North)
