Reply to Q. No. 25 – In this connection, it is informed that the opinion of Hon'ble Attorney General of India was obtained by POWERGRID and not by the Government of India. However, the opinion was duly considered by the Committee constituted to decide on RoW compensation and accordingly the compensation for land cost for tower base as well as for corridor was recommended by the committee and notified by the Ministry of Power. The guidelines of Ministry of Power, as notified on 15.10.2015 was duly accepted by POWERGRID immediately in November, 2015 for implementation subject to adoption of same by the State Government as per point No. 4 of the Ministry of Power Guidelines.

Reply to Q. No. 26 - Since the transmission system implementation by POWERGRID Warora Transmission Limited has not yet commissioned, there is no profit as on date. As regards, POWERGRID CSR details, these are available on POWERGRID website (www.powergridindia.com) and can be seen from there.
