**Grounds of Appeal**

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60025 dated 18<sup>th</sup> March, 2018 from Sh. Vivek Gupta. Earlier, the appellant herein had filed an application bearing number PGCIL/R/2018/50117 dated 8<sup>th</sup> February 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking following information:

“Duties of Supervisor in POWERGRID's Transmission line construction and his right to issue Notice of Crop, Tree or Land compensation to Farmers”

Appellant has preferred the instant appeal on the ground that requisite information was not provided to him within the time limit. On receipt of the Appeal, details were sought from CPIO. CPIO has informed that vide letter dated 16<sup>th</sup> March 2018, information was provided to the appellant. Copy of the same attached with this order.
