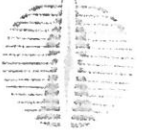

Subject: Reply to Public Grievance (Registration no. MPOWR/P/2017/00301) registered on the Public Grievances (PG) portal- reg.

This is with reference to your grievance registered on Public Grievance Portal pertaining to POWERGRID.

In this regard, as per information received from concerned Region, we wish to inform you the following:-

- i. In the Year 2006, you were deployed as a S/Man Security Guard under the contract for 'providing Security & Surveillance service at POWERGRID Rourkela S/s, Odisha' by the Agency: M/s Dynamics Security, 162/1, Motibagh Village, Nanakpur, New Delhi-110021 (Branch Office at Beramal Krishna Chowk, Near Prince Wine Shop, Jharsaguda, Odisha-8).
- ii. Further, Sh. A K Panigrahi was under deployment as a S/Man Security Guard w.e.f. 01.03.2008 under the contract for providing Security & Surveillance service at POWERGRID Rourkela S/s, Odisha' by the Agency: M/s PEE-EM Security, Nayak Building, Beramal Chowk, P.O-Industrial Estate, Jharsuguda, Odisha.
- iii. Both the appointments were purely Contractual, under the said contract and under the sole discretion of the Agency. The above contracts were awarded in line with DGR guidelines and Norms of the Corporation (POWERGRID).
- iv. Full payments (payable as per the contract provisions) have already been disbursed to Sh. Panigrahi through the above Contract Agencies during the tenure of respective contracts along with other Security Personnel. Also, Arrear Payments (so arrived on implantation of Wage per DGR-Base Structure) had already been disbursed to Sh. Panigrahi in April-2007 and August- 2007 through the above Contract Agency.

As per records, during above tenure(s) of deployment, you were involved in following highly Indiscipline and unruly activities:-

- a. Non-punctuality in duty timing,
 - b. Non-seriousness in duty (Roaming here and there, leaving the allotted security post-unmanned, during duty hours),
 - c. Absconding from duties (during the allotted Shift duty Hours) in un-authorized manner,
 - d. Provoking to fellow security guards for signature on plain paper,
 - e. Threatening to fellow Guards,
 - f. Making fellow Guards to perform their duty under fear.
- vi. With your presence in POWERGRID, Rourkela, the Safety and Security of the Substation were under a great threat.
- vii. As, such indiscipline and unruly act could not be anticipated from an ex-Army Personnel and could not be tolerated within functioning of such a vital Installation of National Importance, the security Agency: M/s PEE-EM Security transferred you from POWERGRID, Rourkela to HPCL, Jatni (where their operations were in force), but you refused to accept the transfer.
- viii. Finally the Agency (M/s PEE-EM Security) withdrew your deployment from the scope of their Security contract with POWERGRID, Rourkela.

This issues with the approval of Competent Authority.
