**Grounds of Appeal**

The Appellate Authority has received an online Appeal bearing number PGCIL/A/2018/60023 dated 15<sup>th</sup> March, 2018 from Sh. Vivek Tiwari. Earlier, the appellant herein had filed an RTI application bearing number PGCIL/R/2018/50142 dated 12<sup>th</sup> February 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking following information:

"Photocopies of Question Paper of all recruitments exams(written) conducted in last five years (between 01.01.2013 to 29.01.2018) for Post of Diploma trainee(Civil) and Field supervisor(Civil) for all regions including POSOCO mentioning exam date with advertisement number."

On receipt of the appeal, information provided to appellant by CPIO vide letter dated 26<sup>th</sup> February 2018, and relevant papers were perused.

The appellant herein is seeking the photocopies of question papers of recruitment exams conducted in the last five years for the post of diploma trainee (civil) and field supervisor (civil). I am of the considered view if the information regarding question papers is provided, POWERGRID will be at loss as those questions will no longer be part of the question bank maintained by the corporation and POWERGRID will not be able to use those questions for future examinations.

The Appeal is accordingly disposed of.
