No. CC/02/2018 dtd. 22/01/2018) for the post of Assistant Engineer Trainee (E1) through GATE 2017, it has been mentioned that -- selected candidates will be paid a consolidated stipend of Rs. 24500/- per month. And also mentioned that -- pay scale mentioned above is subject to modification/revision.</p>
Reply	<p>So I have question that: Will stipend be fixed of 24500/- per month even after revision or it will be changed after revision.</p> <p>The query pertains to a future event and accordingly answer to this query does not qualify as "information" as per clause 2(f) of the RTI Act 2005.</p> <p>However, it is to inform that pay scales in POWERGRID are currently due for revision. After revision of pay scales, the amount of stipend may be considered for revision as per management's discretion.</p>
