Under RTI Act, I seek the following information regarding the recruitment of Assistant Engineer Trainee (Electrical) through GATE 2017	
1	Approximate date of issue of call letters for GD/Interview
2	Possible dates of selection interviews
Reply 1 & 2	The requested information pertains to a speculation and does not come under the purview of the RTI Act, 2005.
3	Whether the applicants who are currently pursuing higher studies on the basis of GATE 2017 score (and hence unlikely to join POWERGRID on specified date, in case of selection) would also be issued interview call letters
4	Whether the applicants who are already employed in other PSUs, but filled false information regarding this in the POWERGRID application form would also be issued interview call letters
Reply 3 & 4	Call letters for GD and Interviews are issued to eligible candidates who are shortlisted as per notified criteria.
5	Whether the applicants whose qualifying certificates were issued after 31.12.2016 would also be eligible to appear for the recruitment process.
Reply 5	Please refer to para C of the section "Eligibility Criteria" in the detailed Advt. No. CC/02/2018 dated 22.01.2018 hosted on our website, where it is mentioned that " <i>... Only those candidates who possess the above qualification as on last date of application are eligible.</i> "
