Query: Land in which 400kV, 220kV and 132kV GIS Substations constructed, under Construction.

Reply: The land requirement for GIS substation varies from substation to substation depending primarily on the following factors:

- 1) Number of Voltage levels in the substation
- 2) Number of EHV Lines and direction of Line take off corridor
- 3) Number/type of transformer & reactor
- 4) Future expansion requirement
- 5) Fire fighting requirement
- 6) Store requirement
- 7) Infrastructure requirement i.e Township, Transit camp, Parking, security etc.

 Exact land used in already constructed/under construction substations shall be collected

from respective RHQ/site offices. The typical area requirement for 400/220kV and 220/132KV substations shall be in the following range:
