**1. Is there any policy for reservation in promotion for person selected/recruited under handicapped/specially abled category working in government organization/public sector/Govt. undertaking companies.**

Reply: The guidelines issued by Government of India is followed for the reservation in promotion for person selected/recruited under handicapped/specially abled category working in POWERGRID.

**2. If yes, please provide details of respective policy/rule.**

Reply: Three Percent (3%) of the vacancies in case of promotion to Group D and Group C are reserved for persons with disabilities of which 1% each shall be reserved for persons suffering from (i) blindness or low vision, (ii) hearing impairment and (iii) loco motor disability or cerebral palsy in the posts identified for each disability as per Disabilities (equal opportunities, protection of rights and full participation ) Act, 1995.
