

## Reply to RTI Queries by Sh. Pankaj

Query 1	Is PGCIL giving <u>pay protection</u> to central govt employee who joined PGCIL <u>after retired</u> from govt department.
Reply	Please refer to clause 3.1.4 of POWERGRID's Pay Fixation Rules reproduced below:  "The pay of a re-employed pensioner of the Central Government on his initial re- employment shall be fixed as per the Central Government Rules prevalent from time to time. The working formulae based on the existing Central Government Rules are given at "Annexure-I" for reference. If the appointment is not the first re-employment after retirement, the pay of the re-employed pensioner will be fixed by the appointing authority or an authority empowered in this regard by the appointing authority, on the basis of principal enunciated at rule 3.1 above subject to the condition that the actual pay to be drawn by him shall be the pay so fixed minus the pension and pensionary equivalent of other retirement benefits as under the Central Government Rules."  The above mentioned "Annexure I' is also enclosed with this RTI Reply.
Query 2	What is <u>pay fixation rule/</u> policy <u>for the retired defence person who joined organisation soon after retirement</u> . As current policy/ manual does not give clear picture about fixation of pay
Reply	Relevant guidelines of DoPT/DPE shall be followed in such cases.

Formula for calculating Pension Equivalents of Gratuity (PEG)

Death-cum-retirement gratuity/CPF as at 3
PEG =

Commutation factor corresponding to age on next birthday x 12

- A. Actual pay to be allowed is X in the scale offered
- B. Graded relief allowed by the Central Government from time to time is to be adjusted against the dearness allowance payable in the Company.
- \* To be restricted at the minimum of the pay scale, except in situations specified in G.O.I. decision No-1 below F.R. 22 and subsequent decisions/clarifications.

## NOTE:

The working formulae as above will serve only as guide. The detailed Central Government Rules as contained in Fundamental Rules may however be referred to for further guidance.
