Grounds of Appeal


1. Final Marks of all the candidates who have given interview for the post of Assistant Engineer Trainee Civil Gate 2017.

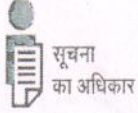
The Appeal is accordingly disposed of.

Sir,

This has reference to your online RTI request dated 7th June, 2018 for providing information under RTI Act, 2005. Point wise reply to the queries are given below:

Point No. 1

Joining process of AET through GATE 2017 is yet to complete. Once the joining process is over, GD/Interview/total marks of any particular candidate can be provided subject to clause 8(1) (j) of the RTI Act, 2005.

Point No. 2

In interview, candidate is required to obtain 40%, in case of UR category, and 30% for reserved category for empanelment. Final merit is decided on the basis of 85% weightage of GATE marks out of 100, 12% weightage to interview marks out of 100 and 3% weightage to GD marks out of 20.

First Appeal, if any, against the reply of CPIO may be made to the first appellate Authority within 30 days of the receipt of the reply of CPIO. Details of Appellate Authority at Corporate Centre, Gurgaon, under RTI Act, 2005 is as below:
