

Circular HR Circular No : 411/2018

Sub: Establishing equivalence of posts in POWERGRID with Posts in Government for establishing Creamy Layer criteria in OBC category -regarding.

1. DPE Vide OM dtd, 25.10.2017 has clarified that for determination of creamy layer criteria in OBC Category i.r.o. CPSE employees, all Executive posts in CPSEs i.e. Board level and below Board level executives which are managerial level posts will be considered as "Creamy Layer". However, such Executives whose annual income as per criteria given in DOPT OM dtd, 08.09.1993 is less than Rs 8 lakhs, will not fall under the Creamy layer.
2. Accordingly, only those OBC category Executives whose annual income is Rs 8 lakhs and above in POWERGRID shall be considered as 'OBC-Creamy Layer' Category.
