This has reference to your RTI request dated June 20, 2018 for providing information under RTI Act, 2005. Point wise reply to the queries are given below:

Point No. 1 & 2

The information sought regarding the Transmission projects undertaken by POWERGRID since 2003 requires compilation of more than 15 years of data, which shall divert resources of the public Authority. However, the applicant may refer to the information regarding Transmission projects under Section-62 of the Electricity Act, 2003 undertaken by POWERGRID since 2007, generally available at its Website link <http://www.powergridindia.com/investment-approved-board>. In regard to decision regarding such projects, it may be informed that the Transmission projects are conceptualized & finalized after deliberations in respective Standing Committee, Regional Power Committee Meetings & Empowered Committee Meetings and minutes of all such deliberations, recommendations are generally available at the Website of CEA – <http://www.cea.nic.in/pspandai.html>.

Point No. 3 & 4

POWERGRID is not aware of basis of quoting award of developing now transmission corridors mentioned in news article being granted to POWERGRID.
