PUBLIC NOTICE

The Government of India has envisaged a greater role for the Open and the Distance Education System. The envisioned role may be fulfilled by recognizing and treating the Degrees/Diplomas/Certificates awarded through distance mode at par with the corresponding awards of Degrees/Diplomas/Certificates obtained through the formal system of education. Open and Distance Education System in the country is contributing a lot in expansion of Higher Education and for achieving target of Gross Enrolment Ratio, without compromising on quality. Non recognition/non equivalence of degrees of Open and Distance Learning (ODL) institutions for the purpose of promotion/employment and pursuing higher education may prove a deterrent to many aspiring students and will ultimately defeat the purpose of Open and Distance Education.

Accordingly, the Degrees/Diplomas/Certificates awarded for programmes conducted by the ODL institutions, recognized by the erstwhile DEC/UGC, in conformity with UGC Notification on Specification of Degrees should be treated as equivalent to the corresponding awards of the Degree/Diploma/Certificate of the traditional Universities/Institutions in the country.

UGC has notified *UGC (Open and Distance Learning) Regulations, 2017* in the official Gazette on **23/06/2017**. As per UGC (Open and Distance Learning) Regulations, 2017 under Part-I (2)(p), the programmes in engineering, medicine, dental, pharmacy, nursing, architecture, physiotherapy and such other programmes which require hands-on training are not permitted to be offered under Open and Distance Learning mode.

सं.एफ.6-1/2013-डीएल—जबकि, भारत के राजपत्र भाग-1, खण्ड-1, में 1 मार्च, 1995 को प्रकाशित भारत सरकार, मानव संसाधन विकास मंत्रालय (उच्चतर शिक्षा विभाग) की अधिसूचना संख्या 44 द्वारा यह निर्णय लिया गया था कि संसद अथवा राज्य विधान मंडल के किसी अधिनियम द्वारा स्थापित विश्वविद्यालयों, विश्वविद्यालय अनुदान आयोग अधिनियम, 1956 की धारा 3 के अन्तर्गत विश्वविद्यालयवत् संस्थाओं और संसद के किसी अधिनियम के अन्तर्गत घोषित राष्ट्रीय महत्व की संस्थाओं द्वारा दूरस्थ शिक्षा के माध्यम से प्रदान की गई सभी अर्हताओं को केन्द्र सरकार के अधीन पदों और सेवाओं में रोजगार के प्रयोजन के लिए स्वतः ही मान्य माना जाएगा, बशर्ते इन्हें दूरस्थ शिक्षा परिषद, इन्दिरा गांधी राष्ट्रीय मुक्त विश्वविद्यालय, नई दिल्ली और जहां आवश्यक हो, अखिल भारतीय तकनीकी शिक्षा परिषद, नई दिल्ली द्वारा अनुमोदित कर दिया गया हो।

और जबकि, मानव संसाधन विकास मंत्रालय, उच्चतर शिक्षा विभाग ने दिनांक 29 दिसम्बर, 2012 और 25 फरवरी, 2014 के अपने आदेश द्वारा उच्चतर शिक्षा प्रणाली में शिक्षा की मुक्त और दूरस्थ शिक्षा (ओडीएल) पद्धति के विनियामक कार्य विश्वविद्यालय अनुदान आयोग (यूजीसी) को सौंपे हैं।

और जबकि, इन्दिरा गांधी राष्ट्रीय मुक्त विश्वविद्यालय ने दिनांक 01 मई, 2013 की अपनी अधिसूचना द्वारा विश्वविद्यालय की दूरस्थ शिक्षा परिषद को भंग कर दिया है।

अतः अब केन्द्र सरकार एतद्वारा यह अधिसूचित करती है कि संसद अथवा राज्य विधान मंडल के किसी अधिनियम द्वारा स्थापित विश्वविद्यालयों, विश्वविद्यालय अनुदान आयोग अधिनियम, 1956 की धारा 3 के अंतर्गत विश्वविद्यालयवत् संस्थाओं और संसद के किसी अधिनियम के अंतर्गत घोषित राष्ट्रीय महत्व की संस्थाओं द्वारा मुक्त एवं दूरस्थ शिक्षण पद्धति के माध्यम से तकनीकी शिक्षा सहित प्रदान किए गए डिप्लोमा/डिग्रिया/प्रमाणपत्र केन्द्र सरकार के अंतर्गत पदों और सेवाओं में नियोजन के प्रयोजन से स्वतः ही मान्यता प्राप्त हैं बशर्ते, उनका विश्वविद्यालय अनुदान आयोग से अनुमोदन हो।

[EXTRACT FROM THE GAZETTE OF INDIA, PART I—SEC. 1, dated 25th July 2015]

MINISTRY OF HUMAN RESOURCE DEVELOPMENT

(DEPARTMENT OF HIGHER EDUCATION)

New Delhi, the 10th June 2015

No. F. 6-1/2013-DL—Whereas by the notification of the Government of India in the Ministry of Human Resource Development (Department of Higher Education) Number 44 dated 1st March, 1995 published in the Gazette of India, Part I, Section 1, it had been decided that all the qualifications awarded through Distance Education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section 3 of the University Grants Commission Act, 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government, provided they have been approved by Distance Education Council, Indira Gandhi National Open University, New Delhi and wherever necessary by All India Council for Technical Education, New Delhi.

And whereas the Ministry of Human Resource Development, Department of Higher Education vide its order dated 29th December, 2012 and 25th February, 2014 has entrusted the regulatory work of Open and Distance Learning (ODL) mode of education in the higher education system to the University Grants Commission (UGC).

And whereas, Indira Gandhi National Open University vide its notification dated 1st May, 2013 has dissolved the Distance Education Council of the University.

Now, THEREFORE, the Central Government hereby notifies that all the degrees/diplomas/certificates including technical education degrees/diplomas awarded through Open and Distance Learning mode of education by the Universities established by an Act of Parliament or State Legislature, Institutions Deemed to be Universities under Section 3 of the University Grants Commission Act, 1956 and Institutions of National Importance declared under an Act of Parliament stand automatically recognized for the purpose of employment to posts and services under the Central Government, provided they have been approved by the University Grants Commission.
