ORDER

Grounds of Appeal

The Appellate Authority has received a postal appeal dated 28th May, 2018 from Sh. Parveen Kumar. Shri Kumar has filed the instant appeal on the ground that the information sought by him vide his RTI application dated 16th April 2018 was denied by CPIO, citing section 8 (1) (j) of the RTI Act, 2005. The Appellant vide his appeal dated 28th May, 2018 is seeking following information:

- Name of Shortlisted Candidates under reserved category (with experience details), Shortlisting Criteria, and Name of Selection Committee Members along with designation for Advt. No. CC/03/2017 dated 29th July, 2017 (Post ID- 158) and Advt. No. CC/04/2016 dated 30th April, 2016 (Post ID- 137).
- Interview Date, Result Date and Name of selected candidates against Post ID- 158 Advt. No. CC/03/2017.

Decision:

On receipt of the appeal, information provided to appellant by CPIO vide letter dated 22nd May 2018, and relevant papers were perused. CPIO has already provided information regarding Shortlisting criteria, designation of selection committee members, Interview date, result date and registration ID of selected candidates as desired by the appellant. I am of the considered view that names of the selected candidates for post ID-158 and names of the shortlisted candidates for post ID-137 can also be given to the appellant as the process for selection for aforementioned POST IDs', stands completed. CPIO is hereby directed to provide the names of the selected candidates as well as the shortlisted candidates to the appellant within two weeks from the date of this order.

With the above direction and observations, the appeal is disposed of.
