## Information sought:

Following Information has been sought under Right to Information Act 2005 as mentioned at Para 5:-

"In the order No. 4 (13)/2016-5D(1) dated 09.08.2016 Ministry of Steel (MOS) give instruction to the various department along with POWERGRID that selection of steel shall not be classified under primary steel or secondary steel but should be classified only by the prescribed BIS standards by MOS".

1. Whether POWERGRID follows the above said order of MOS while selection of steel for construction in various project?

2. If no, then which norms/standards POWERGRID follows for selection of steel?

## REPLY:

In this regard it is to intimate that the steel for construction projects is being procured by the respective contractors from the approved vendors. We are following the instructions, in the order, issued by MOS and vendors are approved after physical assessment.
