The Notification and order have been posted on the website of the Steel Ministry steel.gov.in also.

- 2. It has come to notice that despite removal of any classification as to Primary or Secondary producer, etc., the user Departments are still continuing with this Classification. In this connection it is once again reiterated that this Ministry has no classification in terms of Primary & Secondary Producers. Further, the route of steel making i.e. whether primary or secondary, ordinarily has no bearing on the quality of steel. Also, with the mandatory BIS Certification requirement on a large number of steel products, the concerns of quality of steel can easily be addressed by insisting on BIS certified steel products.
- 3. You are hence requested to sensitize the PSUs and other Organizations/bodies under the administrative control of your Ministry and ensure that suitable changes are made in the Internal Procurement Guidelines.

Sir/Madam,

I am directed to refer to the Notification of this Ministry dated 12.5.2016 and also the Order issued on 9.8.2016(copies enclosed) regarding Classification of Steel Plants in the country. The Notification and order have been posted on the website of this Ministry <u>steel.gov.in</u> also.

- 2. The Notification dated 12.5.2016 of this Ministry specifically states that "No Steel producers will be classified/certified as Integrated Steel Producers, Primary Steel Producers, Secondary Steel Producers, Main Producers, Major Producers or Others by Ministry of Steel or JPC". The Notification also stated that "the listing will be purely for statistical purpose and will have no bearing on the quality of steel produced. It is up to the users to ascertain the quality of the steel products to be procured, as per relevant standards". Further, this Ministry has also issued a Clarificatory Order dated 9.8.2016, which was circulated to Major infrastructure Ministries/Departments as well as to all Steel Associations.
- 3. Complaints/Grievances are being received from various organizations of steel industry that despite clear orders that no steel producers will be classified as Main/Major/others by this Ministry, user Departments like CPWD/Railways, etc are not changing their procurement policies and continuing to offer a step-motherly treatment to the products of smaller manufacturers. This is despite the fact that products of smaller producers are meeting BIS standards and are competitively priced.
- 4. In view of the above, it is reiterated that the listing of Producers by JPC will be purely for statistical purpose only and will have no bearing on the quality of steel produced. It is up to the users to ascertain the quality of the steel products to be procured, as per relevant standards". It is also requested that the above Notification and Order of this Ministry may be adhered to while issuing tender / work order, etc by

the User Ministries/Departments, which would ensure a level playing field to all Producers/Industry Associations of Steel Industry. It is also requested that the above Notification may be brought to the notice of the PSUs/Autonomous bodies under the administrative control of your Ministry/Department.

NOTIFICATION

No. 8(1)/2015-TD (Vol-IV) in supersession of this Ministry's Notification No. 4(8)/2010 - SD-I dated 24.04.2015 on classification of Steel Plants/ Producers, revised guidelines for classification of Steel Producers is hereby issued as follows:

- 1. Steel Producers with their registered office addresses will be listed Plant & location wise in accordance with crude steel capacity in descending order indicating process route adopted for iron making and steel making with or without rolling/ finishing operations, as the case may be, and product-mix by Joint Plant Committee (JPC), Kolkala.
- 2. Where iron making/ steel making/ rolling operations are in different locations, the same will be listed suitably location wise under the same producer, as long as all operations are carried out by the same company or its subsidiary companies.
- 3 JPC will maintain the list of steel producers on its website which can be accessed on payment basis.
- 4. The list will be updated on annual basis, based on the previous year's data to be submitted by the steel producers to JPC or information available with them.
- 5. The listing will be purely for statistical purpose and will have no bearing on the quality of steel produced. It is upto the users to ascertain the quality of the steel products to be produced, as per relevant standards.
- 6. No Steel producers will be classified/ certified as 'Integrated Steel Producers', 'Primary Steel Producers', 'Secondary Steel Producers' 'Main Producers, 'Major 'Primary Steel Producers' or 'Others' by Ministry of Steel or Joint Plant Committee (JPC). The Producers' or 'Others' by Ministry of Steel and/or JPC Kolkata prior to this classification/ certification issued by Ministry of Steel and/or JPC Kolkata prior to this notification on classification of steel producers/plants, stands withdrawn and becomes null and void with immediate effect.

ORDER

With the abolition of classification in Steel Producers in India vide notification No. 8(1)/2015-TD (Vol. IV) dated 12th May, 2016 no steel producer is to be classified/certified as 'Integrated Steel Producers', 'Primary Steel Producers', Secondary Steel Producers', Main Producers, 'Major Producers' or 'Others' by Ministry of Steel. However, Ministry of Steel has issued Quality Control Orders on 30 non-alloy steel and 3 stainless steel products which cannot be produced, sold, stored for sale, distributed and imported, without certification by Bureau of Indian Standards (BIS) and without Standard Mark of BIS.

2. Major Infrastructure Ministries/Departments, like Railways, Defence, Shipping, RTH, UD, Power, Mines etc. while calling for tender /etc. may like to bring these facts to the notice of their major PSUs also.
