**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal PGCIL/A/2018/60062 dated 2<sup>nd</sup> July, 2018 from Sh. Amit Kumar. Earlier, the appellant herein had filed an application PGCIL/R/2018/50370 dated 31<sup>st</sup> May 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking following information:

1. Has the interview for the posts advertised vide Advt. No. CC/05/2017 dated 21.11.2017 been conducted or not ?
2. If not ,When the interview for the posts advertised vide Advt. No. CC/05/2017 dated 21.11.2017 is likely to be conducted ?
3. How POWERGRID will inform a candidate to be called for interview?

Appellant has filed an appeal on the ground that he could not receive requisite information from CPIO within the time Limit. On receipt of the Appeal, the details were sought from CPIO. CPIO has provided the details to the appellant vide letter dated 18<sup>th</sup> June 2018.

## Decision

I am of the view that the information sought by the appellant herein has already been provided by the CPIO vide letter dated 18<sup>th</sup> June 2018. Copy of the Letter is again attached with this order for the perusal of the appellant.

The Appeal is accordingly disposed of.



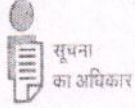
