ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal PGCIL/A/2018/60114 dated 12th December, 2018 from Sh. Amandeep Singh Bedi. Earlier, the appellant herein had filed an application PGCIL/R/2018/50396 dated 9th June 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking information regarding his eligibility for recruitment in POWERGRID on ground of his medical condition.

Appellant has filed the instant appeal on the ground that CPIO has not provided the response within the prescribed time limit. On receipt of the Appeal, the details were sought from the CPIO. CPIO has informed that the information has been provided to the appellant vide letter dated 21st June 2018. The letter was dispatched to the applicant through Speed Post No. EH644811499IN dated 21st June 2018.

Decision
