**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal PGCIL/A/2018/60074 dated 20<sup>th</sup> July, 2018 from Sh. Mudit Jain. Earlier, the appellant herein had filed a RTI application PGCIL/R/2018/50421 dated 18<sup>th</sup> June 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID, seeking following information:

1. His score in GD and personal interview and overall marks obtained, for the final merit list of Recruitment of AET (EE) through GATE 2017.
2. Total marks obtained by each student in the merit list in each section (GD, Interview, GATE marks).
3. Highest and lowest marks obtained in the merit list students wise and their individual marks in GATE, GD and Interview.

Appellant has filed this appeal on the ground that he did not receive requisite information from the CPIO within the time Limit. On receipt of the Appeal, the details were sought from the CPIO.

## Decision

I Have perused the information provided by the CPIO vide letter dated 9<sup>th</sup> July 2018. It can be seen that vide the aforementioned letter the CPIO has provided the information to the appellant regarding his overall marks as well as his score in GD, and Personal Interview. A copy of the letter dated 9<sup>th</sup> July 2018 is once again enclosed with this order. It has also been informed by the CPIO that the recruitment process is not over yet hence, the information sought at serial number 2 and 3 cannot be provided, I agree with the view of the CPIO.

The Appeal is accordingly disposed of.
