<b>Query</b>	<p>If in a recruitment two ministries are involved and fault done by only one ministry, how will the candidate get justice?</p> <p>For example in a campus recruitment of NIT Srinagar by PGCIL two ministries are involved Ministry of Power and Ministry of HRD.</p> <p>And fault has been done by NIT Srinagar (Directly comes under HRD Ministry) and admitted the mistake in writing.
