

Reply to RTI Query by Sh. Ashish Kumar Yadav i.r.o. recruitment for the post of AET through GATE 2017

Query 1	Category wise final cut off marks after interview and rank of last candidate who got selected.
Reply 1	GATE cut-off marks for shortlisting of candidates for interview is annexed at Annexure-I. In interview, candidate is required to obtain 40%, in case of UR category, and 30% for reserved category for empanelment. Final merit is decided on the basis of 85% weightage to GATE marks (out of 100), 12% weightage to Interview marks and 3% weightage to GD marks.
Query 2	Marks of candidate with registration ID-500337
Reply 2	Reg. Id-500337, Name :- Ashish Kumar Yadav, Personal Interview(Out of 100)-52, GD marks(out of 20)-10 and total marks including GATE 2017 score in prescribed weightage(Out of 100)- 53.0280.
Query 3	Number of vacant seats after medical examination.
Reply 3	Total number of candidates to whom offer of appointment issued initially, who have not reported for medical examination, is 17 (EE-11, EC-1, CE -05).
Query 4	When the second list of candidates will be issued for filling the vacant seats.
Reply 4	The query pertains to a future event and accordingly answer to this query does not qualify as "information" as per clause 2(f) of the RTI Act 2005. However, substitute offer to 17 candidates (EE-11, EC-1 and CE 05) is already issued.
