I am making the instant application pursuant to and under the relevant provisions of the Right to Information Act, 2005 as well as the judgment dated 20.03.2018 delivered by the Hon'ble Supreme Court of India in Common Cause v. High Court of at Allahabad & Anr. being Writ Petition (Civil) No. 194 / 2012 wherein the Hon'ble Supreme Court has laid down the recent guidelines vis.-a-vis the Right to Information.

The Economic Times, Delhi Edition published a news article titled "PGCIL may get Big Pie of Transmission Corridors" published on 28.05.2018 at Page No.11 wherein, it was stated that the Central government plans to award a big chunk of new transmission corridors worth Rs 25,000 crore to Power Grid Corp (PGCIL) on nomination basis citing urgency. In this respect I seek the following information:

I seek information with regard to the number of projects granted to PGCIL since 2003 on the basis of strategic importance or technical upgradation as envisaged under National Tariff Policy and developed under Section 62 of the Electricity Act, 2003, instead of opting for bidding route as provided under Section 63 of the said Act for allocation of transmission corridors?
 2. I seek the nature of strategic importance on the basis of which the transmission corridors have been allotted to PGCIL under Section 62 of the Electricity Act, 2003, since the year 2003.
 3. Please take note that I have deposited the requisite fees of Rs. ~~100/-~~ 50/- (which is the maximum chargeable fee for an RTI as per the Hon'ble Supreme Court of India's judgment dated 20.03.2018) through a demand draft drawn on Kotak Mahindra Bank dated 20th June 2018 being No. 836698.
 4. That I am a 'Citizen' of India and I am asking the information as a 'Citizen'.
 5. I assure that I shall not allow/ cause to use/ pass/share/display/ or circulate the information received in any case and under any circumstances, with any person or in any manner which would be detrimental to the Unity and Sovereignty or against the Interest of India.
