No facilities and services provided to FTB in comparison to permanent like no vehicle for site,no gift from department(safety gift, vigilance gift all r provided to permanent employee not to FTB why the partiality this much),not even any place in Office to sit. 3. Not given the opportunity to appear for the departmental exam of Powergrid (by saying from HR side that you will not be entitled with TA/DA and leave for departmental exam)are we departmental candidate or not as compared to NR1 region with NER. 4. In NR1 FTB employees are treated as departmental employees but not in NER . TA /DA facilities are provided as well as leave for departmental exam but not in NER. 5. EQUAL PAY FOR EQUAL WORK is the organisation follow bec. there are many employees who are on FTB and are not getting the pay what they deserve as compared to permanent employees for same work. In a significant verdict, the Supreme Court has held that the principal of equal pay for equal work has to be made applicable to those engaged as daily wagers, casual and contractual employees who perform the same duties as the regulars. It said in view of different constitutional provisions and the law declared by the Court under Article 141 of the Constitution, the principle of equal pay for equal work constitutes a clear and unambiguous right and is vested in every employee, whether engaged on regular or temporary basis.
