Dear Sir,

This is with reference to PTC letter referred at (i) requesting for part operationalization of 174MW LTOA from Teesta-III HEP (6x200 MW) to UP, out of 1200MW LTOA granted to PTC. Subsequently, CTU vide letter referred at (ii) had circulated agenda to all the stakeholders for part operationalization of the subject LTOA requesting comments/observations, if any, by 16.04.2018. Pursuant to above, POSOCO vide letter referred at (iii) proposed that the requisite LTOA may be part operationalized subject to commissioning of 400 kV Dikchu – Rangpo line so as to ensure N-1 reliability. Upon receipt of comments/observations, CTU vide letter referred at (iv) informed that the LTOA may be part operationalized subject to commissioning of 400kV Dikchu – Rangpo line.

Further, TUL vide letter referred at (vi) again requested for part operationalization of above LTOA immediately without linking with the commissioning of 400kV Dikchu –

Rangpo section. Accordingly, a meeting was held at POWERGRID office, Gurugram among CEA, CTU, POSOCO, PTC, TUL and TPTL on 04.05.2018 wherein it was decided that subject part LTOA may be part operationalized and in case of any claim raised by UP regarding curtailment of LTOA due to outage of Teesta-III – Rangpo section, the same shall be settled bilaterally by PTC with UP. Further, PTC shall submit an undertaking to keep CTU and POSOCO indemnified till commissioning of Dikchu – Rangpo section of 400 kV Teesta-III – Kishanganj D/c line. In this regard, PTC vide letter referred at (viii) has also submitted an undertaking mentioning that they shall keep CTU and POSOCO indemnified against any claim on account of operationalization of 174MW LTOA from Teesta-III to UPPCL till commissioning of 400 kV Dikchu – Rangpo section.

In view of the above, the aforesaid part LTOA for transfer of 174MW power to UP from Teesta-III HEP, Sikkim may be operationalized as per details below:

- a. 174 MW w.e.f. 12.05.2018 to 31.03.2031
- b. 168 MW w.e.f. 01.04.2031 upto 25 years from start date of LTOA at (a) above.

In this regard, it is to mention that for the subject part LTOA operationalization, PTC is required to open LC of requisite amount for which you may contact at the following address for signing the referred agreements.
