**Reply to RTI Query by Sh./Smt. Christina Rani A pertaining to recruitment for ET(Law).**

<b>Query 1</b>	<b>Why there is no reservation for the above mentioned post for PwD candidates? (There is no details given in the detailed add no. CC/03/2018 and in 1&amp; 2 notifications too)</b>
<b>Reply 1</b>	PwD reservation is provided based on entire vacancies occurring in Group A. There is no fresh vacancy occurring for PwD for ET-Law post.
<b>Query 2</b>	<b>If providing how many seats will be allotted and what will be eligible cut off marks for PwD</b>
<b>Reply 2</b>	As already advertised and also mentioned above, no seat is reserved for PwD in the post of ET(Law) advertised vide advt No. CC/03/2018. Hence there will not be any separate shortlisting for PwD and accordingly no separate cut off shall be there for PwD.
<b>Query 3</b>	<b>If not, why there is a concession for application fee and separate column for PwD details.</b>
<b>Reply 3</b>	Concessions to any category is different from reservation. PwD candidates are provided concession in application fees. They are also provided age relaxation irrespective of reservation. Moreover, categories/ subcategories of PwD identified suitable for any post has also been notified by Govt. Hence PwD details are captured in application form to check the eligibility of such candidates w.r.t. the above conditions.
