Engineer Electrical and exam held on 07.07.2018 having reg. no. 901142.</p> <p>I want to know the following mentioned below:</p> <ol style="list-style-type: none">(1) What Marks I scored in exam(2) Cut off marks in my category(3) How many candidates called for interview(4) There was only screening criteria for selection of candidate for interview. Why cut off marks criteria details not informed to me before written exam.
Reply	<ol style="list-style-type: none">(1) Your Marks in screening test : 30.67 %(2) Cut off Marks in Unreserved Category: 40 %(3) Candidates called for interview : 102 Nos.(4) As per our advertisement dated 21.11.2017: <i>"The Management reserves the right to raise the minimum eligibility standards/ criteria and / or to conduct a screening test, to restrict the number of candidates to be called for Personal Interview, if so required."</i> <p><i>The decision of POWERGRID regarding scrutiny of application and shortlisting shall be final and binding. Shortlisted Candidates will have to qualify in the Interview to be adjudged suitable for empanelment for Appointment. The qualifying marks in interview shall be as given below:</i></p> <p>UR – 40%, SC/ST/OBC(NCL)/PwD (LD-OL/ HH) – 30% (Depending on reservation of vacancies only)</p> <p>Considering the large no. of candidates found eligible for the post, screening test was conducted for limiting the nos. of candidates / shortlisting of candidates for interview.</p> <p>Hence, performance of the candidates in the screening test was the basis for shortlisting for interview and POWERGRID has not considered any candidate below 40 % marks in Unreserved category for interview. It may be mentioned that cutoff marks criteria for screening test has been taken same as prescribed for interview.</p>
