# Query 1:

# Query 2:

On what basis was contract given to a non-government company mjunction services limited on nomination basis.

## Reply:

Considering the emphasis of CVC for early implementation of e-procurement by CPSUs, POWERGRID initially had requested DGS&D to implement e-procurement in POWERGRID. Since, the platform of DGS&D was not ready, POWERGRID after assessing their e-procurement system and taking due approvals, appointed M/s. Instrument Limited. Kota (IL KOTA) [(a PSU) supported through electronic tendering portal of M/s. Electronic Tender, New Delhi (ELECTRONIC TENDER)] on Single Tender Basis in September 2008 and extended further till September 2011. As per the road map for complete implementation of e-procurement at POWERGRID, inter-alia the officials and vendors were provided the trainings. The subject contract with IL KOTA, however, was terminated in April 2011 as IL KOTA were facing constraints related to Govt. Guidelines and issues between them and their technology partner ELECTRONIC TENDER.

To continue the e-procurement activities uninterrupted as per the finalized road map for complete implementation of e-procurement at POWERGRID, considering that M/s. Telecommunication Consultants India Limited (TCIL) were using the same engine of ELECTRONIC TENDER (which was being provided by IL KOTA) and another agency M/s. mjunction (MJUNCTION) [a 50:50 JV of SAIL (a PSU) and TATA STEEL] had approached POWERGRID (a letter addressed to Ministry of Power by MJUNCTION had also been forwarded to POWERGRID), POWERGRID after demonstration of their systems, due assessments of their infrastructure, capacity & capability and negotiating the terms & conditions with them and after taking requisite approvals from the Competent Authorities at POWERGRID, appointed both TCIL (with engine of ELECTRONIC TENDER) and MJUNCTION for providing e-procurement services on October 2011.
