Reply 3	The query is vague and not specific regarding any particular Diploma Trainee Examination as Diploma Trainee Examinations are conducted on regional basis. 1- If the candidate submits his/her Roll No. and the Region in which he/ she appeared the examination on which date, the response sheet can be provided. 2- Candidate can raise objection on any question or answer option during the examination in writing on plain paper mentioning his/ her Roll No., question No. and nature of query / complaint and submit the same to invigilator who will forward the same to POWERGRID. 3- Diploma Trainee examination is based on objective type questions. Each question is having 4 answer options. The most correct answer option is to be chosen by the candidate.
