Information Sought Sl. No. 1 : What is policy in PGCIL regarding recovery of Bond amount if an officer leaves PGCIL to join other Central Government departments like Railway after qualifying ESE Examination.

Reply : Bond amount is payable if an officer leaves POWERGRID during the bond period.

Information Sought Sl. No. 2 : In case Bond amount is proposed to be recovered whether it is full amount or proportionate amount to the non-served period only like other CPSUs.

Reply : In case of recovery of bond amount during training period, the total amount of salary, joining expenses, TA/DA, medical expenses etc. paid during the training period and training expenses incurred by the company on account of and in connection with his/her training, subject to the stipulated bond amount, is recovered. However, in case of recovery after training period, the same is recovered on pro-rata basis for the period he/she has served after completion of training period.
