ORDER

**Grounds of Appeal**

The Appellate Authority has received an appeal PGCIL/A/2018/60087 dated 25<sup>th</sup> Sept'18 from Sh. Parijat Patel. The appellant has filed the instant appeal on the ground that he has not received the information as desired by him from the CPIO. The appellant had sought certain information relating to FTB Employees vide his RTI application PGCIL/R/2018/50492 dated 30<sup>th</sup> July 2018.

In his RTI application dated 30<sup>th</sup> July 2018, the applicant raised various issues such as treatment and facilities provided to FTB employees vis-a-vis regular employees, not allowing FTBs to appear as departmental candidate for departmental examinations, treatment given to FTBs by different regions of POWERGRID and demanding equal pay as paid to regular employees.

On receipt of the appeal, information provided to appellant by the CPIO vide letter dated 5<sup>th</sup> September 2018, and other relevant papers were perused.

**Decision:**

I am of the opinion that the CPIO vide his letter dated 5th September 2018 has provided the desired information to the appellant. It is pertinent to mention that the appellant herein has not sought any information in his appeal but views/opinion of the public authority which is beyond the purview of the RTI Act, 2005. Information under section 2(f) of the Act only refers to such material as is available in records of the public authority. Public authority is not obliged to give views/ an opinion, as same is beyond the mandate of the Act.
