सूचना का अधिकार अधिनियम के तहत जानकारी प्राप्त करने के सम्बन्ध में Sh G Sai Krishna Kumar द्वारा मांगी गयी जानकारी से सम्बन्धित प्रश्न के उत्तर के सम्बन्ध में

Information Sought:

- (1) Has POWERGRID implemented the revision of pay and allowances in respect of board level and below board level executives w.e.f. 01.01.2017 strictly as per guidelines contained in DPE OM No. W-02/0028/2017-DPE(WC)-GL-XIII/17 dated 3rd August 2017, OM No. W-02/0028/2017-DPE(WC)-GL-XIV/17 dated 4th August 2017 and DPE guidelines issued vide OM No 2/(12)/2009-DPE(WC) dated 24.12.2012 as per MoP order dated 10th May 2018.
- (2) Is POWERGRID still maintaining multiple levels(DGM, AGM and GM) in one E8 grade after two and half months since the revision of pay scale as per MoP order.
- (3) Are they in accordance with DPR guidelines and MoP order dated 10th May 2018.
- (4) Has POWERGRID made promotion policy from E8 to E9 Grade as on 28.07.2018 after their pay revision order dated 29.05.2018 after merging E7,E7A and E8 levels into E8 grade w.e.f.01.01.2017.
- (5) Has POWERGRID invited candidates placed in GM level (in pre-revised scale before pay revision order dated 29th May 2018) for an interview for promotion from E8 to E9 grade in the first week of August 2018 without formulation the policy applicable for all executives placed in E8 grade since 01.01.2017 after pay revision.
- (6) If Yes, are they in accordance with DPE guidelines and MoP order.

Reply: The information sought by the applicant is in the form of clarification on implementation of DPE guidelines in wage revision of executives and no specific documents has been sought by the applicant. Providing a clarification of the applicant is outside the purview of the RTI Act, therefore, no documents can be provided.
