Information Sought (2): Do you post female candidates, who are graduates in electronics engineering or equivalent branch, in shift duties including night duties.

Information Sought (4): Do you post female candidates, who are graduates in electrical engineering or equivalent branch, in shift duties including night duties.

Information sought (6): Do you post female candidates, who are graduates in mechanical engineering or equivalent branch, in shift duties including night duties.

Reply: Posting of employees of various disciplines is based on requirement of manpower at different locations and assignments which does not differentiate between genders.
