

This has reference to your online RTI request dated 15<sup>th</sup> august, 2018 for providing information under RTI Act, 2005. Point wise reply to the queries are given below:

## Point No. 1

Waist level height of transmission line towers varies for different types of towers depending upon the tower design based on voltage level, wind zone, electrical clearances, angle of deviation, configuration/type of tower and extensions used. For 765 kV S/C wind zone-IV transmission lines, the waist level of Delta & Horizontal configuration towers of normal height in POWERGRID is typically in the range of 20m – 35m & 10m -20m respectively.

2	What nature of maintenance works can be carried out in live line conditions above waist level?	Works like as Tower Top Patrolling Punctured Insulator Detection, and other hotline maintenance works can be carried out in live line condition above waist level.
3	Does POWERGRID permits its regular employee or engaged contractual labor to work above waist level in live line condition.	Powergrid does all routine maintenence works through regular employees only except in extraordinary conditions
4	Do permit to work is required for TLM staff for carrying out maintenance work in 765 kV tower for Delta and Horizontal configuration above waist level.	Yes
5	In case of permit to work is not issued, do message is being logged in respective control room for carrying out maintenance work in 765 kV tower for Delta and Horizontal configuration above waist level.	Yes
6	What system of issuing Permit to work is followed in POWERGRID , i.e, SAP generated or manually generated.	Permit to work is normally generated through SAP.
