I had applied for Assistant Engineer post against advertisement no. CC/05/2017. For this I have given online exam on 7<sup>th</sup> July 2018 in Delhi /NCR. But in results there is no list showing no. of candidates' shortlisted and cutoff marks. I want to know:

Query	1 My marks in online exam
Reply	1 29.67 %
Query	What is cutoff marks
Reply 2	2 30 % for OBC (NCL) category
Query	What is the criteria for shortlisting of candidates
Reply 3	Qualifying marks - 40 % for unreserved vacancies and 30 % for reserved vacancies.
Query 4	Marks of candidates shortlisted for interview and ratio of candidates called for interview
Reply 4	Category wise cut off marks of candidates called for Interview are given below:  UR-40 %  OBC (NCL)- 30 %  SC-31.67 %  ST- 31 %  Only Qualified candidates in the ratio of 1: 3 (1:5 for 1, 2 or 3 vacancies and 15 for 4 vacancies) in each category on the basis of marks obtained in the Screening Test.
Query 5	Shortlisted candidates experience with company
Reply 5	Information sought in respect of other candidates pertains to personal information of third party, the disclosure of which has no relationship to any public activity or interest and which would cause unwarranted invasion of the privacy of the individual. Hence, the information cannot be provided under Clause 8 (1) (j) of RTI Act.
