QUALIFICATION OF THE BIDDER

Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's technical experience and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules.

Technical experience and financial resources of any proposed subcontractor shall not be taken into account in determining the Bidder's compliance with the qualifying criteria. The bid can be submitted by an individual firm or a Joint Venture of two or more firms.

Specific requirements for Joint Ventures are given under Para 1.3 below

The Employer **may** assess the capacity and capability of the bidder, to successfully execute the scope of work covered under the package within stipulated completion period. This assessment **shall** inter-alia include (i) document verification; (ii) bidders work/manufacturing facilities visit; (iii) manufacturing capacity, details of works executed, works in hand, anticipated in future & the balance capacity available for present scope of works; (iv) details of plant and machinery, manufacturing and testing facilities, manpower and financial resources; (v) details of quality systems in place; (vi) past experience and performance; (vii) customer feedback; (viii) banker's feedback etc.

1.0 Technical Experience

1.1 Bidder must have erected, tested and commissioned under a single contract, at least two (2) nos bays of 66kV or above voltage level in one (1) substation or switchyard during last seven (7) years and these bays must be in satisfactory operation# as on the originally scheduled date of bid opening i.e. 06/09/2017.

Note-1 (#) : *Satisfactory operation means certificate issued by the Employer certifying the operation without any adverse remark.*

Note-2 : In case bidder is a holding company, the technical experience referred to in clause 1.1 shall be of that holding company only (i.e. excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the technical experience referred to in clause 1.1 shall be of that subsidiary company only (i.e. excluding its holding company).

1.2 FINANCIAL POSITION:

Bidder must meet the following minimum criteria:

- a) Net Worth for last 3 financial years should be positive
- b) Minimum Average Annual Turnover* (MAAT) of the bidder for best three years i.e. 36 months out of last five financial years as annualized, must be

Rs. 500.91 million for Package SIK-SS-07

* Note- Annual total income as incorporated in the profit & loss account except non-recurring income e.g. sale of fixed assets

- c) Bidder must have Liquid Assets (LA) and/or evidence of access to or availability of credit facilities of not less than

Rs. 83.485 million for Package SIK-SS-07

Note-1 : In case bidder is a holding company, the Financial Position criteria referred to in clause 1.2 above shall be that of holding company only (i.e. excluding its subsidiary / group companies). In case bidder is a subsidiary of a holding company, the Financial Position criteria referred to in clause 1.2 above shall be that of subsidiary company only (i.e. excluding its holding company).

1.3) JOINT VENTURE BIDS

1.3.1 In case a bid is submitted by a Joint Venture (JV) of two or more firms as partners, atleast one of the partner(s) shall meet requirement at para 1.0 and the JV shall meet collectively the requirement at Para 1.2 (b)& (c) above. Further for a JV to be qualified, the partners of joint venture must also comply the following minimum criteria

- i) The Lead partners of the JV shall meet individually the Financial Position criteria given at 1.2 (a) above. And not less than 40% of minimum Financial Position criteria given at para 1.2 (b) & (c) above. **and**
- ii) Each of the other partner (s) individually.
- a) shall meet **either the Technical Experience criteria given at 1.0 above, Or**
- b) shall meet not less than 25% of the criteria given at 1.2 (b) & (c) above

1.3.2 The joint Venture must satisfy collectively the Criteria of clause 1.2(b) & (c) above for which purpose the relevant figure of average annual turnover and liquid assets / credit facilities for each of the partners of the JV shall be added together to arrive at Joint Venture total capacity.

1.4 The bidder shall furnish documentary evidence in support of the qualifying requirement stipulated as above.
