**ORDER**

**Grounds of Appeal**

The Appellate Authority has received an online Appeal PGCIL/A/2018/60103 dated 12<sup>th</sup> November, 2018 from Sh. Mohd. Faisal. Earlier, the appellant herein had filed an application PGCIL/R/2018/50640 dated 3<sup>rd</sup> October 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID seeking following information regarding recruitment number CC/04/2018 for the post of ET (HR) in POWERGRID.

1. How many applications were received for the post ET (HR)?
2. Is there any provision for waiting list after final selection list?
3. Ratio of candidates called with respect to number of seats?


Appellant has filed an appeal on the ground that he did not receive requisite information from the CPIO within the specified time Limit. On receipt of the Appeal, the details were sought from the CPIO.

## Decision

I am of the view that the information sought by the appellant herein has already been provided by the CPIO vide letter dated 20<sup>th</sup> November 2018.

Further, CPIO is also advised to maintain the timeline of 30 days for providing the information under RTI Act 2005.

The Appeal is accordingly disposed of.
