Description

The 400 kV Teesta III – Kishanganj line delay was put up in PRAGATI meeting in Prime Minister Office held on 25-4-2018 wherein decisions were taken for early completion of transmission line by TPTL Teestavalley Power Transmission Ltd (a joint venture of TUL and Powergrid corporation). Whereas the decision in PRAGATI meeting was for completion of project by Sept 2018, the line still remains incomplete.
