ORDER

Grounds of Appeal

The Appellate Authority has received an online Appeal PGCIL/A/2018/60116 dated 14th December, 2018 from Sh. Rahul Kumar Saha. Earlier, the appellant herein had filed an application PGCIL/R/2018/50768 dated 18th November 2018, under RTI Act, 2005 with the CPIO Corporate Centre, POWERGRID, seeking following information.

1. Number of backlog vacancies in ET- ELECTRICAL branch for the year 2017, for General and OBC Category.
2. Will PGCIL clear waiting list in case of any vacancies left, after the application process for ET- ELECTRICAL through GATE 2019 starts?

Appellant has files an appeal on the ground that CPIO has provided incomplete, misleading or false Information. On receipt of the Appeal, the details were sought from the CPIO. CPIO informed that in the information has been provided to the appellant vide its letter dated 6th December 2018. Further CPIO informed that the applicant had seek similar information vide another RTI Application PGCIL/R/2018/50810 dated 14.12.2018 for point No. 2 above and reply of the same has been forwarded to the applicant vide letter dated 9th January 2019.

Decision

I am of the view that the information sought by the appellant has already been provided by the CPIO vide letter dated 6th December 2018 and 9th January 2019. The copies of CPIO's reply are attached for ready reference.

The Appeal is accordingly disposed of.




