

सूचना का अधिकार अधिनियम के तहत जानकारी प्राप्त करने के सम्बन्ध में Sh Arvind Kumar द्वारा मांगीं गयी जानकारी से सम्बन्धित (मा.सं.-औ,अभि. से सम्बन्धित प्रश्न के उत्तर के सम्बन्ध में)

**Information Sought:** As POWER GRID CORPORATION OF INDIA LIMITED published the advertisement for the post of ET(HR) through UGC NET 2018 vide Advt. No. CC/04/2018 dated 13.03.2018 in which the eligibility criteria in terms of Essential Educational Qualification is –

"Two years full time Post Graduate Degree/Diploma/MBA in HR/ Personnel Management & Industrial Relations /Social Work (with specialization in Personnel Management & Industrial Relations)/HRM and Labour Relations / Labour and Social Welfare from recognized University /Institute with not less than 60% marks."

On the other hand, University Grants Commission (UGC), Ministry of Human Resource Development (MHRD) and Department of Public Enterprise (DPE) is directed time to time regarding the recognition of Open and Distance Learning (ODL) mode of degrees for the purpose of employment as same as degree on regular mode while making recruitment in Central Govt. and CPSEs jobs.

So, kindly provide me the information why POWERGRID is not following the guidelines issued by MHRD (as formulating the National Policy on Education and to ensure that it is implemented in letter and spirit), DPE (as following the recruitment rules defined by DPE) and UGC (as POWERGRID is taking the valid score of UGC NET 2018 but not adhering the guidelines of UGC regarding recognition of ODL mode degrees for the purpose of employment). Please specify the reason.

It is therefore, requested you to please consider this issue on priority basis since it is all about the question of National Importance regard to degrees recognized by Statutory authority for the impetus to zillion of students who pursue their ODL education with the motive of Learning by Excellence.

Reply: Vide aforesaid query, requester seems to be seeking justification/reason rather than information and it does not come under the definition of information under the RTI Act.
