Reply:

Ans.1 The required information is being denied under Clause No. 8.1(j) of Right of Information Act, 2005 "information which relates to personal information the disclosure of which has no relationship to any public activity or interest or which would cause unwarranted invasion of the privacy of the individual".
Moreover, under Section 16 of the Sexual Harassment Act the required data cannot be furnished as Act states that "The contents of the complaint, identity and address of the aggrieved woman, respondent and witness, information relating to conciliation and inquiry proceedings , recommendations of the ICC or the LCC and the action taken by the employer or the District Officer shall not be published, communicated or made known to the public, press and media. However information may be disseminated regarding the justice secured to the victim of sexual harassment without disclosing the name, address, identity or any other particulars".
